The successful firm will be assigned the role of administering the provident fund of the Authority's staff

## C. Basic Eligibility criteria

1. Must be registered with the RBA for the current year 2020 and a copy of the current license be submitted as evidence.
2. Furnish the Board/Client with at least five (5) corporate firms whose pension schemes the administrator has managed in the last 5 years. Documentary proof must be attached with premium of fund value of at least KShs 300 million each.
3. Have working experience of at least 5 years as a Pension Scheme Administrator with references.
4. Must submit a copy of the audited accounts for the previous three years.
5. Must have total number of management staff of at least 3 (No).
6. Submit the list of key staff with their curriculum vitae for the purpose of verifying relevant skills and experience.

(b) Valid Tax Compliance Certificate
(c) Certificate of Registration/Incorporation (Certified)
(d) Must have CR12 (Certified)
